

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to [www.CassConcepts.com](http://www.CassConcepts.com), and Cass Concepts and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Cass Concepts include [www.CassConcepts.com](http://www.CassConcepts.com), Cass Concepts, Cass Concepts Productions, Inc. and [www.CassConceptsProductions.com](http://www.CassConceptsProductions.com). The Cass Concepts website is a marketing firm plus production company at Penn Station Theatre site. By using the Cass Concepts website, you consent to the data practices described in this statement.

## Collection of your Personal Information

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

## Sharing Information with Third Parties

Cass Concepts does not sell, rent or lease its customer lists to third parties.

Cass Concepts may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Cass Concepts, and they are required to maintain the confidentiality of your information.

Cass Concepts may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Cass Concepts or the site; (b) protect and defend the rights

### **Automatically Collected Information**

Information about your computer hardware and software may be automatically collected by Cass Concepts. This information can include: your IP address, browser type, domain names, access times and referring website addresses. ### **Use of Cookies**

- SSL Protocol

- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;

- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.
